\$5.10 each for the next 21-50 employees plus
\$4.00 each for the next 51-100 employees plus
\$3.25 each – 101+ employees

Base: \$295.00 plus
\$26.25 per million dollars in deposits

\$1.60 per unit for the first 30 units plus
\$1.05 per unit for the next 31-100 units plus
\$0.70 per unit – over 100 units

Base: \$295.00 plus
\$5.35 per room for the first 125 rooms plus
\$2.45 per room – over 125 rooms

PROFESSIONAL

*Accountants, Attorneys, Architects, Chiropractors,

Investors, Optometrists, Physicians, and Veterinarians*

Base: \$295.00 (includes one professional) plus
\$150.00 for each additional professional plus
\$10.25 for each office/support staff

REAL ESTATE

Base: \$295.00 (includes broker and office) plus
\$295.00 for each licensed real estate agent
(equals a separate business account) plus
\$10.25 for each office/support staff

UTILITIES

*Telephone, Water, Gas, Electric, and Cable Television
Companies*

Base: \$665.00 (includes one person) plus
employee assessment as defined under
"Diversified" category, above

ASSOCIATE MEMBERSHIP

*Includes non-business owners and organizations such
as: City Government, Clergy, Clubs and Organizations,
County Commissioners, Education, Farmers,
Legislators, Non-Profit Organizations without Staff,
Postmasters, Retired Persons, Senior Citizens and
Centers, Part-time Specialty Businesses.*
